Summary:

On 03-06-2023, at approximately 1733 hours, I responded to Mugsy's Tavern and Grill for a report of a disturbance.

Location:

7161 Main Street, Bonners Ferry, Boundary County, Idaho.

Narrative:

On scene, I contacted Bonners Ferry Police Sergeant Cowell inside the Mugsy's meeting room, which is separated from the rest of the restaurant by a wall and door. The room was crowded and I followed Sergeant Cowell to the doorway where Adrienne Norris approached us. Norris began asking if she should, "e-mail it" to the involved parties or just, "you guys." Sergeant Cowell began answering Norris' question, when she interrupted saying, "I can't listen to you," saying he had involvement, but did not specify what that involvement was. Norris told me Sergeant Cowell was related and she did not feel comfortable talking to him however, she did not specify how, Sergeant Cowell was related, nor to whom. At the same time, Sergeant Cowell was attempting to explain she would not be telling him and another Officer would be conducting the investigation. I told Norris I was there to assist the City Police. Norris asked me if I knew who she was. I said I did not. Norris told me her name and said, "I'm the watchman." Norris stated that if the issue was handled correctly, "I will not post this to everybody." I told Norris I did not care (if she posted) and explained I did not know what the watchman was. Norris told me she was giving me the opportunity to handle the situation correctly, explaining there was, "distrust in the community." Norris told me she knew about me saying I have had, "a few cases." At that point, Bonner Ferry Police Corporal Garrett arrived and I exited the building to speak with Sergeant Cowell. Sergeant Cowell told me his mother-in-law, Danielle Ahrens, was one of the involved parties. I agreed to take the investigation due to Sergeant Cowell's conflict of interest and conducted several interviews on scene.

I spoke to witness Caleb Davis, first. Davis told me his interpretation was there had been a lot that preceded the incident. Davis said that the committee went into executive session due to one of the involved parties, "blowing up." Davis told me an executive session is when everyone who is not a part of the committee leaves the room and recorders are turned off. Davis told me that Mark Moseley was being verbally aggressive during the executive session, however, he did not get physical. Davis told me at the end of the executive session, he, Davis, got up to let everyone back into the room, when he saw Danielle Ahrens moving Moseley's belongings from Davis seat, so Davis could take his place as chairman. Davis told me he had sat in a different location due to feeling uncomfortable, sitting next to Moseley. Davis told me things escalated. Moseley and Ahrens crossed paths, Moseley was, "a man with a mission" and they, "collided" when they crossed paths, referring to Ahrens and Moseley. Davis told me he had never seen Ahrens be aggressive before and if anything, he, (Moseley), had been, "goading" everybody. While confirming Davis' information, I asked him to introduce me to the other involved parties, specifically, Ahrens. From the entrance to the meeting room, Davis pointed out Ahrens and Moseley. I thanked Davis, telling him I would contact him later if I had further questions.

I approached Danielle Ahrens and asked if it was a good time to speak. She said it was and followed me outside, away from the other involved parties. I asked Ahrens what was going on that night. Ahrens told

me they were in executive session and having a problem with Moseley. Ahrens is a member of the republican committee. Ahrens told me Moseley was constantly, verbally attacking people and then physically coming in to, "intimidate," them. Ahrens explained that Davis had to give up his seat, due to feeling, "physically unsafe," around Moseley. Ahrens told me she had a background in law enforcement and told Moseley he was going to move, as she picked up Moseley's belongings and carried them to another table. Ahrens said she then told Moseley he could take his, "rightful position." Ahrens told me Moseley got, "really angry," grabbed her belongings, came around the table and threw her phone on the ground. Ahrens told me Moseley ran into her, "like a body check." I asked Ahrens to specify what part of Moseley contacted her. She replied, "with his body." Ahrens told me she was already disabled and had eight fusions in her lower back and neck. Ahrens told me she, "pushed," Moseley away from her and he went into some chairs and said, "I've been assaulted call the police." Ahrens told me she was in fear of Moseley continuing his push and that she would fall down on the floor, so she reacted by, "throwing my body weight back into him," to maintain her upright position. Ahrens told me she thought Moseley was being, "dramatic" and fell on purpose. I asked Ahrens if she wanted to press charges. Ahrens said no, explaining Moseley may be pressing charges. I requested Ahrens write a statement regarding this case, which she agreed to do. I asked Ahrens if she had any questions. Ahrens told me she and the committee had continuing problems with Moseley threatening them and, "posturing." I explained to Ahrens that I did not know anything about their organization, or its rules. I told Ahrens that if the establishment they hold their meetings at said Moseley could not be there and trespasses him, that was something I could work with. I left Ahrens and went to return to the meeting room.

On my way, I gave Norris my business card and requested she provide me with a written statement. Norris requested to speak with me separately. Norris explained she had been dissatisfied with a call for service I had taken some time in the past. Norris spoke with me regarding several other traffic related issues. I told Norris I was sorry and she continued discussing traffic issues. In closing, Norris told me she would not post this incident online, unless she felt the case was not being taken care of properly. I told Norris I was indifferent and told Norris her freedom of speech was none of my business. Norris told me she liked that and left the scene.

I approached Moseley in the meeting room and asked him to speak with me outside, which he agreed to do. Moseley asked me for a business card, which I gave him. I asked Moseley to later provide me with a written statement, which he agreed to do. I asked Moseley to tell me what happened that night. Moseley told me the executive session was ending and Ahrens started picking up his belongings, including his cameras and audio recording gear and walked off with them. Moseley told me Ahrens had an, "arm full" of things and he yelled at her several times, "put that back, put that back". Moseley told me he was across the room and he may have the incident recorded on another camera. Moseley told me Ahrens would not put his thing down and started to exit. Moseley told me he reached over the table and would not grab her. Moseley told me he grabbed Ahrens cell phone and put it in a chair, hoping she would drop his belongings. Moseley told me Ahrens went into a, "rage," threw his things down on a table, walked over, grabbed Moseley, started shaking him and, "hit" him. Moseley explained he tried to push Ahrens away from him and walk away several times. Moseley told me Ahrens would not stop until several other people started yelling and pulling her. Moseley then explained he did not remember how it actually ended, saying people just, "approached her from behind". I asked Moseley to clarify someone intervened. Moseley said, "yes, several people intervened." Moseley told me Ahrens was trying to throw him to the ground and he was unsure if Ahrens tore his jacket. Moseley told me Ahrens was in an,

"uncontrollable, violent, rage". I asked Moseley if that was the end of the altercation. He said it was. I asked Moseley if he wanted to press charges. He said yes. I asked Moseley if he wanted medical attention. He declined. I asked Moseley if he had anything else he would like to add, that he had not yet communicated. Moseley told me, "Outside of facts that's all I have." I asked Moseley to provide me with any video he may have and explained how to do so. I explained to Moseley how I would forward my report to the Prosecutor's Office. Moseley asked, "she's not going to jail." I explained the Clarke decision as it pertains to misdemeanor arrests, for crimes committed outside my presence. I also explained there was a conflict of interest with the City Police and asked Moseley if he had any issue with me handling the case. Moseley said he had no issues. I left Moseley and entered the bar area.

I asked an employee if I could speak with a manager. I spoke to co-owner, Nick Morelli. I asked Morelli for the video footage from the meeting room. Morelli told me he could pull it up, however, he had not provided video before. We agreed to work on it at a later time. I asked Morelli if he wanted anything done with the people involved. Morelli told me he wanted the responsible party trespass. I told Morelli I had not reviewed any video to determine who was at fault and he agreed to wait until the video could be reviewed before deciding.

I returned to the meeting room and spoke to Corporal Garrett. Corporal Garrett told me he had interviewed Moseley's 21-year-old son, Mitchell Moseley and one other person. For further information regarding Corporal Garrett's interviews, please see his attached supplemental report and body camera footage. Ahrens was in the room. I told her Moseley wished to press charges and explained how that would work. Corporal Garrett agreed to complete a supplemental report, which will be attached to this report. Corporal Garrett also told me he would provide me with his body camera footage.

On 03-07-2023, at approximately 1521 hours, I contacted Nick Morelli at Mugsy's. Morelli and I reviewed the security footage of the confrontation between Ahrens and Moseley. The footage depicted the following. Ahrens and Moseley picking up each other's belongings after the executive session. Ahrens placing Moseley's items at a side table. Moseley placing Ahrens items on a chair, along the wall, next to the side tables. Both Ahrens and Moseley walking toward each other. In the video it appears Moseley walked directly towards Ahrens and before making physical contact, Ahrens grabbed Moseley's coat, at his right shoulder and somewhere near his left shoulder, which is out of frame. The video depicts Ahrens pushing Moseley into a chair, causing him to fall. Ahrens maintains intermittent, physical contact with Moseley, asking him to return her belongings. Ahrens lets go of Moseley's arm, after he tells Ahrens her belongings are across the room. Ahrens and Moseley continue to argue over who took what and accuse each other of assault. Sergeant Cowell arrives on scene shortly after the altercation. At the time, neither Morelli, nor I, knew how to download the footage from the DVR. I gave Morelli my contact information, so he could contact me when the footage was available.

Over the course of several days, I received the following. A written statement from Mitchell Moseley, a written statement from Daniel Norris, Corporal Garrett's body camera footage, Mark Moseley's e-mailed written statement and video on a USB drive, Danielle Ahrens' e-mailed written statement and Adrienne Norris' video on a USB drive. I also spoke to Nick Morelli by phone. Morelli told me he was having issues with the video being in a watchable format. I told him we could meet soon to work on the issue and download the video. We agreed to meet at Mugsy's on 03-14-2023, at about 1500 hours.

On the afternoon of 03-13-2023, I spoke to Mark Moseley by phone. Among other subjects, I spoke to Moseley regarding his request that he, or I, amend his written statement. Moseley made this request in

an e-mail received by me on 03-12-2023, at approximately 1039 hours. I told Moseley I could not ethically change his written statement however, he could submit an additional statement. If I receive any additional statements from Moseley, I will forward them to the Office of the Boundary County Prosecuting Attorney in a timely manner.

On 03-13-2023, at approximately 2115 hours, I responded to Mugsy's to retrieve the security video of the incident, after receiving a phone call from Nick Morelli. I met with Morelli who gave me a USB drive containing the requested footage. While on scene, Morelli and I resolved the format issue, by viewing the footage using VLC media player.

I later reviewed the footage, which was in the form of several files, at the Boundary County Sheriff's Office. Some of the files were not viewable, as they were likely not downloaded correctly. I am forwarding all files with my other digital recordings, regardless of playability.

All written statements received thus far will be attached to this report.

All collected video of this incident has been sent to the Office of the Boundary County Prosecuting Attorney.

Closing Statements:

This case is to be referred to the Office of the Boundary County Prosecuting Attorney for review of charging Danielle Ahrens with the crime of battery I.C. 18-903.

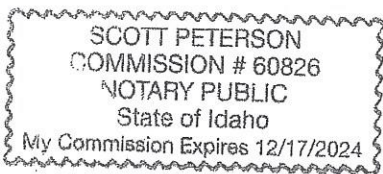

## SUMMARY

The Boundary County Republican Central Committee (BCRCC) was in executive session. Just prior to the assault, Danielle Ahrens (Danielle) was making strange, threatening remarks to me such as "she knows who my attorney is" and "she knows about my cases on file". I found this to be strange behavior, but noted it and moved on.

As the executive session ended, and we were getting ready to allow people back into the room, I (Mark Moseley), got up, and walked across the room to turn back on one of the cameras that I use to record the public meetings.

As soon as I got across the room, Danielle walked over and stole my personal property that included a notebook, a camera, eyeglasses and paperwork that were located on the table where I was sitting.

I turned on the camera and yelled out for her to put my things back, and that she had no right to take my things. She continued to walk toward the bathroom with my things. I feared she might throw my property into the toilet located close to where she was standing.

I decided to not go after her to take my property back. In an effort to stop the incident, and coerce her into putting my property down, I moved her cell phone to a chair near the entrance to the room.

She then dropped my property onto the table, moved toward me and attacked me. She grabbed me, and started shaking me, violently. She tried several times to pull me to the ground while shaking me.

I moved away, while she was attacking me, and I yelled out to Caleb Davis several times to call 911. Caleb Davis stood by, and did nothing to attempt to stop the assault while it was taking place. He did not yell out, or help. He left the room shortly after the assault.

Seconds before the assault began, Adrienne Norris came in and her cell phone was recording. This video recording caught the entire assault. Several people came into the room and witnessed the assault.

The police came into the room, and Danielle told them that I was the one who assaulted her. This was a lie that she told to police. She gave a false statement to police about a crime that she committed. This is recorded on video, and she should be charged for this crime, as well as the assault.

On Monday, March 6th at 6pm I attended the Boundary County Republican Central Committee meeting at Mugsys Restaurant in Bonners Ferry, Idaho. The Police had been notified earlier in the day that they would need to be aware of the volatile situation at our meeting. Our last meeting Mark Moseley when asked to give his report he stood up and walked around the tables briskly and up towards Chairman Caleb Davis. Mark was leaning over the table and yelling at Caleb while red faced and spittle was flying out of his mouth all the while shaking some papers at him and talking about the Pinkerton family. Mark was clearly out of control and scaring people.

I Our meeting Monday night started with Mark sitting in the Chairman's seat at the head of the table and refusing to move by saying if you want me to move you will have to do it physically. Caleb decided to sit at the side of the table so as to defuse the situation. I was sitting at the head table since Precinct Committeeman Dave Wenk is our Secretary and he was out of town so I was filling in for him as Secretary. I made sure that there was a chair between myself and Mark Moseley as you can see on the recording as I am afraid of him and his volatility. During our meeting Mark is becoming more and more aggressive and our County Commissioner Ben Robertson suggests that we go into executive session and our State Committeeman Eric Olson makes a motion to do this, which we do. As we are in executive session tempers are flaring and there are sharp exchanges so it's decided that we cannot resolve things so then we go out of executive session. I then said to Caleb come up and sit here at the head of the table and take your rightful place as our chairman and he said no I'm afraid of Mark so I said well this is ridiculous so I took Marks stack of papers and the camera that was trained on Caleb and I move it 4 seats over to where Mark always sits on the side. As I am doing this Mark is yelling Theft! Theft! Do you see this?and then he grabs my phone. I say Mark, give me my phone, give me my phone! and he comes around the end of the table towards me and throws my phone on the floor. As he is coming at me I know that he is angry, red faced, wild eyed and yelling. I also know that he has assault charges and terrorist threats in when he lived in Texas. I know that he has had numerous run ins with different branches of law enforcement and is actively suing Boundary County Sheriff Department and the Boundary County Prosecutor's Office. I have seen him bully, yell, and attempt to intimidate many men and women here in Boundary County. I am a retired law enforcement officer and I was a Corrections Officer in a Maximum Security Unit. I am also a 63 year old disabled grandmother that walks with a cane sometimes due to being in a car accident that broke my lower back in two places and crushed my spinal cord in my neck so my balance is very precarious and I have 8 fusions in my spine so when I fall down it is very difficult to get back up. I also have PTSD from two very abusive marriages. I'm telling you this back story so that you understand my frame of mind as Mark came aggressively around the end of the table and threw my phone on the ground. I was in fear for my life as he came at me and I took action to neutralize the threat as soon as I could.

As soon as I got across the room, Danielle walked over and stole my personal property that included a notebook, cell phone, a camera, eyeglasses and paperwork that were located on the table where I was sitting.

My Oakley eyeglasses were broken. When I got to my seat, I found them on the floor and appeared to have been stepped on. Danielle Ahrens dropped them when she picked up my things, and she most likely stepped on them and broke them.

I turned on the camera and yelled out for her to put my things back, and that she had no right to take my things. She continued to walk toward the bathroom with my things. I feared she might throw my property into the toilet located close to where she was standing.

I decided to not go after her to take my property back. In an effort to stop the incident, and coerce her into putting my property down, I moved her cell phone to a chair near the entrance to the room.

She then dropped my property onto the table, moved toward me and attacked me. She grabbed me, and started shaking me, violently. She tried several times to pull me to the ground while shaking me.

I moved away, while she was attacking me, and I yelled out to Caleb Davis several times to call 911. Caleb Davis stood by, and did nothing to attempt to stop the assault while it was taking place. He did not yell out, or help. He left the room shortly after the assault.
